Abstract of Issue:
 Safe Rider Instructions

Reason For Release:

Safety is the combined responsibility and effort by the ride manufacturer, the owner/operator and the patrons. In conjunction with the safety features provided by the manufacturer, additional safety precautions must be observed by the owner/operator and the patron.

Patrons must be instructed as to proper seating and behavior before boarding the ride. Passengers must follow all instructions during the entire ride cycle.

Action to be Taken:

All owner/operators of the above noted amusement rides must ensure that all passenger safety considerations are observed. They must provide signage and safety announcements and/or other appropriate communications to instruct passengers about safe rider practices and proper behavior on the ride.

Chance Rides Manufacturing, Inc. has developed a safety sign to remind passengers of the importance of being properly seated. One sign must be mounted to the door frame on the inside of each vehicle so that it can be read by passengers while they are seated in the ride. (See illustration on following page.)

Order and install the Safety Sign Kit (part number K106CRM156-0) within 60 days of the release date of this bulletin. The kit includes enough parts to complete the installation for one complete ride, as follows:

The kit will be made available at a reduced price for 30 days from the release date of this bulletin.

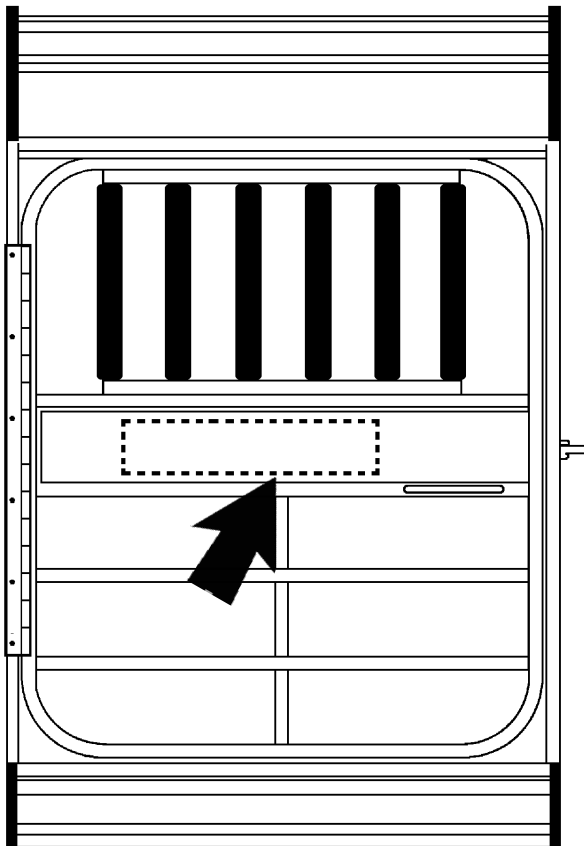

**Rider Safety Instruction Sign
(part number 1060181-001)**

Install on INSIDE of door frame crossmembers as shown.



1. Locate the sign as shown, then transfer the mounting holes to the door frame.
2. Drill 6 holes, 1/8" diameter, through one side of the steel tube.
3. Install the sign using the rivets provided.
