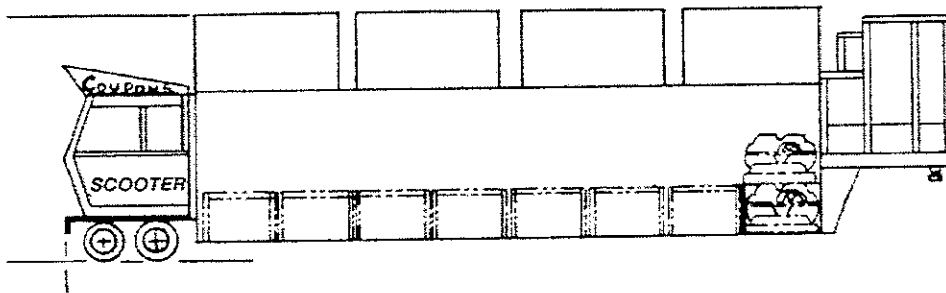

### **Notice:**

Service Bulletin 91-1 and the safety decal referred to; emphasize the importance of maintaining the hoist system to "FACTORY STANDARDS". This supplemental letter is being supplied to all of our customers explaining what the phrase "FACTORY STANDARDS" means.

### **DECK OPERATING CABLES:**

1. Inspect hoist cables for:
  - A. Rust appears to come from the interior of the cable.
  - B. Evidence of previous corrosion from the pitted condition of the wires.
2. Severe stretching occurring in a short section of a cable indicated by a reduced diameter in the cable.
3. Severe damage such as "kinking", broken strands or "bird caging" of the cable.
4. Any strand or strands broken 5% or more.
5. If cables are found damaged they must be replaced. **Both** cables must be replaced at the same time.

### **12-VOLT BATTERY:**

1. Must be at a "FULL CHARGE" at all times to insure proper operation of the 12-volt winch motor.
